If no average last year, use highest USBC average of at least 21 games at time of entry, Rule 319a-1-2-3. All others bowl scratch, 185 for men & 175 for women. Non-league bowler can qualify by paying \$21.00 affiliate USBC member fee, Rule 300c. Men and women's participation fee is \$5.00, Rule 300c. Possible re-rating depends on winning over \$300 per event within 12 months, the rule specifically states that this applies to ALL entrants, men and women, USBC Rule 319d. Any bowler who falsifies his or her average will forfeit all prizes and fees, Rule 319e. Springfield Deaf Club also has the right to reject any entry. Report any obvious scoring error immediately to the tournament chairperson before 8 PM that night. Entries close prior to last squad, Rule 312b.
